Sage Moves to Subscription Model for Payroll Module What it Means to You

eginning on May 1, 2016, existing users of the Sage 100 Payroll module will experience a change. Sage has moved to a subscription-based pricing model for the Payroll module, meaning that it is no longer covered under the Sage Business Care plans, and requires a separate payroll subscription.

Sage announced the change in October, and you may have already received information directly from Sage regarding the transition. Here are some additional details that may prove helpful.

Key Dates

New packaging and pricing for Sage 100 Payroll will launch:

- April 18, 2016, for businesses purchasing Sage 100 U.S. Payroll for the first time.
- May 1, 2016, for existing Sage 100 U.S. Payroll customers.

How is Pricing Determined?

The price you will pay for your subscription is based on the total employees that are active across all your Sage 100 company codes. The maximum number determines your pricing tier.

Should you exceed your current tier during the year, you receive a notice from Sage that you need to upgrade the tier for the purposes of payroll subscription.

What's Included in the Subscription?

The payroll subscription includes:

- Tax table updates
- Direct deposit
- Use of payroll provided you are active under a payroll subscription plan
